The Keya Paha County Commissioners met Tuesday, June 8th, 2021 as advertised. Chairman Nilson called the meeting to order at 10:05 with Commissioners Tuerk and Ritterbush and Clerk Wentworth present. Nilson note the open meetings act posted for the public. After review, Nilson moved, Ritterbush seconded to approve the minutes of the previous meeting held on May 25, 2021. Voting: Nilson—yes, Tuerk—yes and Ritterbush—yes, all voted in favor, motion carried.

After review, Nilson moved to approve the Clerk, district Court Clerk and the Treasurers monthly reports, Ritterbush seconded. Voting: Tuerk—yes, Ritterbush—yes and Nilson—yes. All voted in favor, motion carried.

Ritterbush moved to have the chairman sign the Highway 20 Law Enforcement Agreement, Nilson seconded. All voted in favor, motion carried. This interlocal agreement is renewed every year.

After discussion with Cherry Co Commissioners and Co Attorney Scott via conference call Tuerk authorized Chairman Nilson to enact and sign the Emergency Management Interlocal Agreement with Cherry County Ritterbush seconded. Voting: Ritterbush—yes, Nilson—yes and Tuerk—yes, all voted in favor. Motion carried.

The commissioners took a break for lunch.

C. Giles with BKR Extension office met with the commissioners to discuss replacing the car used for the extension activities. The percentage of the cost for Keya Paha County will be \$673.75, this amount will be added to the next fiscal years budget. Nilson moved to approve the purchase of the vehicle, Ritterbush seconded. Voting: Nilson—yes, Tuerk—yes and Ritterbush—yes, all voted in favor. Motion carried.
