

The Keya Paha County Commissioners met Tuesday, September 14th 2021 as advertised. Chairman Nilson called the meeting to order at 10:00 with Commissioners Tuerk and Ritterbush and Clerk Wentworth. Nilson referenced the open meetings act posted for the public. After review, Nilson moved to approve the minutes of the previous meeting as presented, Ritterbush seconded. Voting: Nilson—yes, Tuerk—yes and Ritterbush—yes. All voted in favor, motion carried.

Nilson moved to accept the Clerk, District Court Clerk and Treasurer's monthly reports as presented from the Clerk and Treasurer, Ritterbush seconded. Voting: Tuerk—yes, Ritterbush—yes and Nilson—yes, all voted in favor. Motion carried.

T. Wyrick and L. Smith met with the commissioners to discuss the continuing FEMA projects. Smith will gather the information needed for some specific projects.

The commissioners went to lunch.

D. Kienke and K Olson both representing the NCDL discussed the counties membership and that the rate will be going to \$5,000 annually. It would be determined by the both boards what percentage of the membership is paid by the village and county. Olson stated that there has been a great deal of monetary benefits to the county in the last year through the help of the NCDL, naming the grocery store as one project.

At 1:59 p.m. the chairman declared the meeting adjourned to hold the tax request hearing, the budget hearing and the special meeting to adopt the budget resolutions. The regular meeting will reconvene at the end of the special meeting.
